## **Day 1- October 15, 2021**

### **1st SESSION (12:00 - 2:15 PM)**

- The National Advisor introduced the 64th Council Members to the General Council and the National Secretary introduced the Treasurer Designees.
- **62nd Audit Presentation:**  
Ex-Secretary presented the Audit Report of the 62nd year, queries were taken up by Ex-National Secretary and Ex-National Advisor.
- **63rd Audit Presentation:**  
The National Secretary presented the Audit Report of the 63rd year, queries were taken up by the National Secretary and National Advisor.
- **Discussion on Amendments in Constitution:**
  - **Article 1 Name of the Association** was presented by the National Advisor, the article got proposed by Z310 and seconded by Z122, no counter proposal hence the article got adopted to the constitution.
  - **Article 2 Vision** was presented by the National Advisor, the article got proposed by Z105 and seconded by Z220, no counter proposal hence the article got adopted to the constitution.
  - **Article 3 Objectives** was presented by the National Vice President, the article got proposed by Z315 and seconded by Z310, no counter proposal hence the article got adopted to the constitution.
  - **Article 4 Admission to the Association** was presented by the National Treasurer, queries from Unit Council were taken up by the National Advisor and National President. The article got proposed by Z122 and seconded by Z329, with no counter proposal hence the article got adopted to the constitution.
  - **Article 5 Rights and Privileges of Observer Colleges** was presented by the Zonal President Zone 1, the article got proposed by Z310 and seconded by Z122 no counter proposal hence the article got adopted to the constitution.
  - **Article 6 Upgradation to Member College of NASA India** was presented by the Zonal President Zone 2, the article got proposed by

Z315 and seconded by Z329, no counter proposal hence the article got adopted to the constitution.

- **Article 7 Rights and Privileges of Member Colleges** was presented by the Zonal President Zone 3, queries from Unit council were taken up by the National Advisor and National President. ### **2nd SESSION (3:15 PM- 4:45 PM)**

- **Discussion on Amendments in Constitution:**
  - **Article 9 Governance Structure** was presented by the Z156, queries from Unit Council were taken up by the National Advisor and National President. The article got proposed by Z310 and seconded by Z122, with no counter proposal hence the article got adopted to the constitution.
- The National Vice President presented the structure of Committees.
- Detailed discussion on the new structure of Trophies.

### **3rd SESSION (5:30 PM- 9:15 PM)**

- Motion of the meeting was followed by the voting and these were the results-
  - Out of 67 Units who voted, **56 were in favour of the Restructuring trophies of Group A and B.**
  - Out of 67 Units who voted, **36 were in favour of Removing College Ranking.**
  - Out of 67 Units who voted, **39 were In favour of Including Group B trophies in Le Corb**

- Out of 67 Units who voted, **33 were in favour of Le Corb being the criteria for College ranking.**
- **Discussion on Amendments in Constitution:**
  - **Article 13 Zones** was presented by the Zonal President Zone 3, the article got proposed by Z310 and seconded by Z329, no counter proposal hence the article got adopted to the constitution.
  - **Article 14 Zonal Council** was presented by the Zonal President Zone 6, General Council had a long discussion on it and was left to be continued on the other day.
  - **Article 18 Committee** was presented by the Z603, queries from Unit council were taken up by the National President. The article got proposed by Z516 and seconded by Z310, with no counter proposal hence the article got adopted to the constitution.

## **Day 2- October 16, 2021**

### **1st SESSION (10:45 AM - 2:15 PM)**

- **Discussion on Amendments in Constitution:**
  - **Article 15 Elections, Eligibility And Term** was presented by the Z310, GC had a long discussion on it and was left to be continued on the other day.
  - **Article 19 Headquarters** was presented by the Z122, a change in the clause was suggested by Unit council to make Elite Premier Institute to Institute of National Importance. The article got proposed by Z310 and seconded by Z122, with no counter proposal hence the article got adopted to the constitution.
  - **Article 20 Source of Income** was presented by the Z122, the article got proposed by Z603 and seconded by Z315, no counter proposal hence the article got adopted to the constitution.
  - **Article 21 Subscription Fee and Late Fee** was presented by the Z122. **The National Treasurer presented the new subscription fee module,** queries from the unit council were taken up by the National President and National Treasurer. The article got proposed by Z205 and

seconded by Z329, with no counter proposal hence the article got adopted to the constitution.

- **Article 22 Expenses** was presented by the Z313, the article got proposed by Z401 and seconded by Z310, no counter proposal hence the article got adopted to the constitution.
- **Article 23 Operation of Bank Account** was presented by the Z315, the article got proposed by Z310 and seconded by Z603 and Z220, no counter proposal hence the article got adopted to the constitution.
- **Article 24 Audit Report** was presented by the Z405, the article got proposed by Z329 and seconded by Z313, no counter proposal hence the article got adopted to the constitution.
- **Article 25 Design Competitions** was presented by the Z313, the article got proposed by Z313 and seconded by Z329, no counter proposal hence the article got adopted to the constitution.
- **Article 26 Events and Programs** was presented by the Z129, the article got proposed by Z122 and seconded by Z129, no counter proposal hence the article got adopted to the constitution.
- **Article 27 Miscellaneous** was presented by the Z313, the article got proposed by Z603 and seconded by Z606, no counter proposal hence the article got adopted to the constitution.
- **Article 12 Executive Council** was presented, queries from Unit Council were taken up by the National President. The article got proposed by Z103 and seconded by Z310, with no counter proposal hence the article got adopted to the constitution.

### **2nd SESSION (3:45 PM - 8:00 PM)**

- The National President presented a **new model ANC Delegation**.
- Further a detailed discussion of Reuben's Trophy among the General council.
- Motion of the meeting was followed by the voting and these were the results-
  - Out of 81 Units who voted, **33 were in favour of Reubens at ANC having a Jury**.

- Out of 81 Units who voted, **74 were in favor of the proposed structure for ANC Delegation.**
- **Discussion on Amendments in Constitution:**
  - **Article 10 General Body Meetings** was presented by the Z164, the article got proposed by Z310 and seconded by Z603, no counter proposal hence the article got adopted to the constitution.
  - **Article 11 Unit Council** was presented by the Advisor, the article got proposed by Z516 and seconded by Z122, no counter proposal hence the article got adopted to the constitution.

### **Day 3- October 17, 2021**

#### **1st SESSION (11:40 AM - 03:20 PM)**

- Zonal Presidents, Public Relations, Events Head and National Vice President presented their respective Mid-Term Reports to the General Council.
- The National President presented the Operational Guidelines to the General Council.
- **Discussion on Amendments in Constitution:**
  - **Article 14 Zonal Council** discussion continued, the article got proposed by Z603 and seconded by Z310, no counter proposal hence the article got adopted to the constitution.
  - **Article 15 Elections, Eligibility And Term** discussion continue, article got proposed by Z516 and seconded by Z310, no counter proposal hence the article got adopted to the constitution.
  - **Article 16 Impeachment** was presented, the article got proposed by Z122 and seconded by Z603, no counter proposal hence the article got adopted to the constitution.
  - **Article 17 Vacancies** was presented by the National Advisor, the article got proposed by Z603 and seconded by Z310, no counter proposal hence the article got adopted to the constitution.

***All the Articles were approved by the General Council, hence the Constitution gets amended.***

- **The National Secretary presented the Zonal Restructure to the GC and explained the points considered while restructuring the zones-**

- An almost equal number of students in each zone.
- Similar academic schedule of colleges.
- An almost equal number of Member colleges in each zone.

Further queries from Unit Council were taken up by the Executive Council on the proposed structure.
